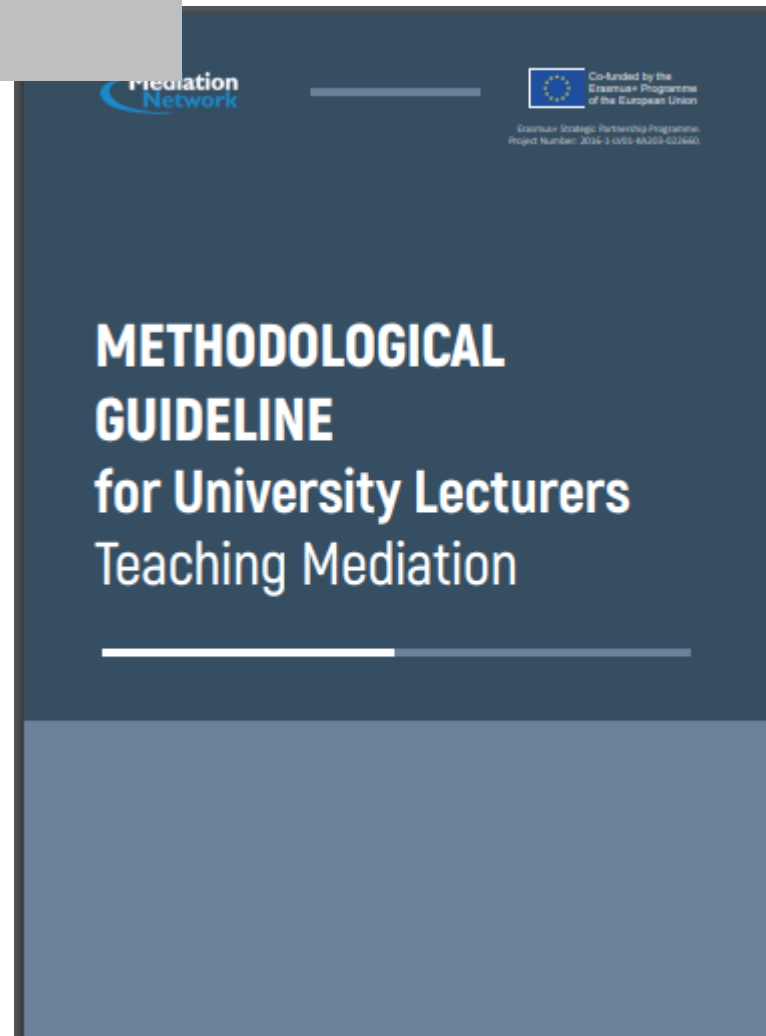

Practical trainings, role plays and tasks requiring active participation of the students are crucial in the education process of young mediators.

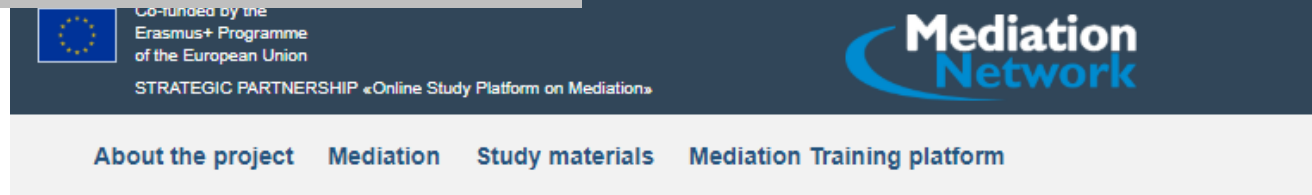
We offer you to try out in your classroom several Criminal and Civil Mediation Cases and Activity tasks related to active listening, rephrasing and controlling emotions.

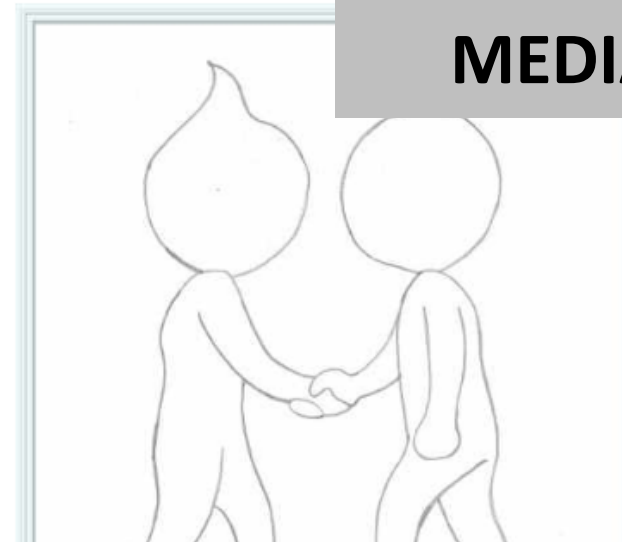

WHAT IS MEDIATION?

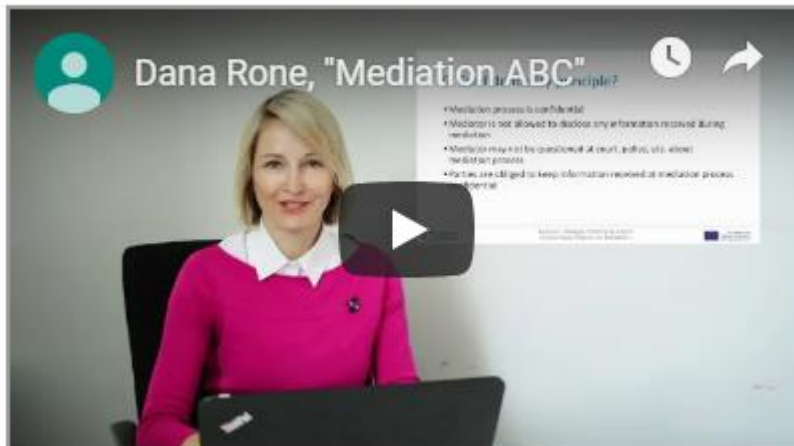
Mediation is a voluntary confidential procedure for out-of-court resolution of disputes - also called alternative dispute resolution. Within the process, a third

party allows the disputants to make a settlement while reaching their interests and his, the parties use the assistance of a professional communication negotiator towards a mutually

agreed solution to their problem and to reach a settlement. The mediator cannot take any side. She/he is simply responsible for facilitating a common sense settlement agreeable
